Vaccines	FALL 2019 Immunizations for School Attendance
DTaP/DT Tdap/Td Diphtheria, Tetanus, Pertussis	K Four (4) or more of DTaP or DT, or any combination. If all four doses were given before the 4th birthday, a fifth (5) dose is required. If the fourth dose was administered at least six months after the third dose, and on or after the 4 birthday, a fifth (5) dose is not required.*
POLIO	K-8 Three (3) or more doses of IPV. The FINAL dose must be administered on or after the 4th birthday regardless of the number of previous doses. If a combination of OPV and IPV was received, four (4) doses of either vaccine are required Grades 9-12 Three (3) or more doses of IPV or OPV. If the third dose of either series was received prior to the fourth birthday, a fourth (4) dose is required; If a combination of OPV and IPV was received, four (4) doses of either vaccine are required.
MMR	K-12
Measles, Mumps,	Two (2) doses of MMR. Dose 1 must be administered on or after the first birthday. The second dose must be
Reubella	administered at least 28 days after dose 1.
HEP B	K-12 Three (3) doses of Henetitis B. The second dose must be administrated at least 00 lb. (6.1).
Hepatitis B	Three (3) doses of Hepatitis B. The second dose must be administered at least 28 days after the first dose. The third dose must be given at least 16 weeks after the first dose and at least 8 weeks after the second dose. The last
	dose in the series (third or fourth dose), must not be administered before age 24 weeks.
Varicella	K-8
(Chickenpox)	Two (2) doses of varicella vaccine must be administered prior to entry. Dose 1 must be administered on or after the first birthday. The second dose should be administered at least three (3) months after dose one (1); however, if the second dose is administered at least 28 days after first dose, it is considered valid. Grades 9-12 One (1) dose of varicella vaccine must be administered on or after the first birthday.

Meningococcal	One (1) dose of meningococcal (serogroup A, C, W, and Y) vaccine must be administered prior to entry <u>Grade 12</u>
	Two (2) doses of meningococcal (serogroup A, C, W, and Y) vaccine must be administered prior to entry
